

Intentions of the Association

Members of the Association are composed of people from all walks of life
who are interested in railroads in general. Although at the present time the
association does not have any steam
equipment, we hope to acquire some steam
equipment. In the way of electric traction cars, we hope to acquire a representative group of mid-western cars.

Visits to the R. R.

Those who wish to visit either for active construction or to inspect the property should follow State Route #161 east from Worthington, Ohio, turning left on Proprietors Road continuing north to the second house on the right side, which is the Black's residence. The property is immediately behind the Black's house. The property is open for inspection to all, although all equipment is kept locked. Keys may be obtained from either V.C. Underwood at the Cay Street address or from George Silcott at the Northington Coal & Supply Company on Route #161.

Equipment, Maintanance, and Right of Way Improvement

Car #21, a wood combine built by
The Niles Car Company in 1904, was given
to the Central Ohio Railfans Association
by the Eastern Ohio Chapter of the National Railway Historical Society in
1946. In April 1946 the car was moved
from the Ohio Public Service Company shops
at Oak Harbor, Ohio, to the Ohio State
Fairgrounds at Columbus, where it was
stored on a siding of the Ohio Department
of Highways until April 1948. Car #21 was
then moved to the present property at
Worthington. The car was in very poor
condition due to vandalism. Thus extensive repairs were necessary, including

the complete replacement of windows (except the gothic arches which were covered with wood until art glass can be obtained), seats, and partial replacement of the roof and side. The old hot water heating system was also removed, and the truck journals rebabitted. The first coat of finish paint was also applied.

The car repairs were made during the earlier months of the year and at the advent of warmer weather, track construction was begun. Rail was obtained from the Federal Glass Company and the farm of Victor A. Ketcham, Jr., a member of the Association. A hand car was donated by Robert A. Young of the Chesapeake and Ohio R.R. The cinders for ballast and part of the used ties were donated by the Pennsylvania Railroad. The rest of the ties were donated by the Columbus & Southern Ohio Electric Company and Chesapeake & Ohio Railway. At the present about 460 feet of track have been laid and ballasted, part of which was old Colum-Delaware & Marion Electric Company right of way. A shed has been obtained from the Black's for storing parts and tools. Trolley ears, span wire, and overhead poles have been donated by the Columbus & Southern Ohio Electric Company.

* * Rail and Line Extension

As we have about 1000 feet of old Columbus, Delaware & Marion Electric Company right of way plus adjoining land purchased, we expect to extend our track at least another 300 feet on the north end of the main line. Overhead poles have been set and even now we have a surplus of these poles. 1000 feet of 000 gauge copper trolley wire has been purchased. The brackets for the poles have been made by the Club, and wire is expected to be strung in the very near future.

Car Barns

Several methods of construction have been considered for the car barns, but no certain one has been decided upon. Plans for the barns, which will be single track temporarily, are now being made.

The most probable material for construction will be concrete block. An alternate method would be to purchase a four car carbarn from the Columbus & Southern Ohio Electric Company, and move it to Worthington.

Power Supply

Although we have no power at the present, the Chio State Museum of the Chio State Archeological Society has taken an interest in the Club, and it is believed that we may be able to procure an electrical generator from them.
